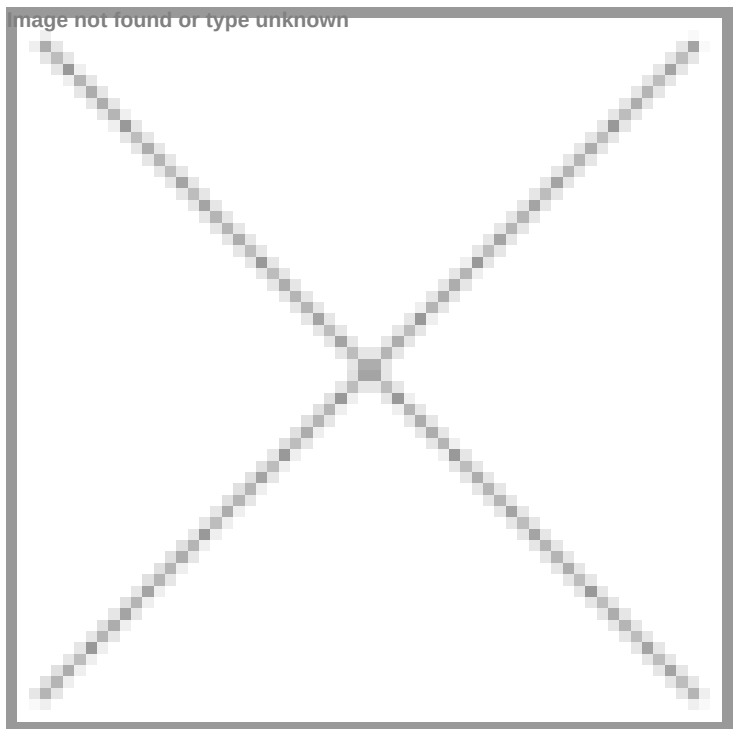


Bain Capital's portfolio company Porus Labs appoints Radhesh Welling as CEO
