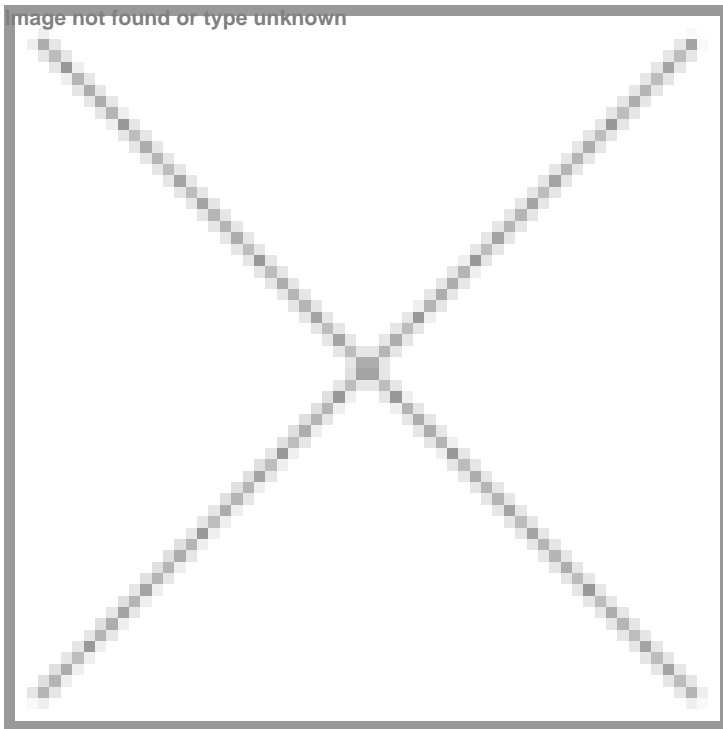


## “Cotecna is actively seeking strategic collaborations to drive innovation in India”
